**ALCOHOL CONSUMPTION on**  
**TOWN PROPERTY POLICY**

At their regular meeting of the Pittsford Selectmen on March 24, 2004, the Select Board approved the following policy in reference to alcohol consumption on Town Property.

The Select Board approved that in order for rental parties to serve alcohol they must have a caterer on site that holds a valid VT liquor license. In addition, said parties are required to hire a constable or special officer to be on duty during the event.

**PITTSFORD RECREATION AREA RULES & REGULATIONS**

- a. The use of any type of off- road vehicle is not permitted within the recreation area or on the trail system, except snowmobiles are permitted on trails within the recreation area as specifically designated by the Selectboard.
- b. All pets must be kept on leashes or similar restraints, except no pets are permitted within the fenced swimming area. Owners will be responsible for removing all pet waste.
- c. The use of or carrying of firearms, bows and arrows, or any other type of dangerous weapons by other than duly authorized law enforcement officers is not permitted.
- d. Cooking fires are permitted in the grills in the picnic area. Portable grills are permitted. All fires must be extinguished upon departure.
- e. Fishing is permitted in Sugar Hollow Brook. Fishing equipment or fishing is not permitted within the fenced in swimming area or swimming pond.
- f. Swimming in the pond is permitted only when lifeguards are on duty.
- g. Use of the swimming area, tennis courts, and group area is permitted upon payment of the daily or annual fees. Proof of payment must be shown upon demand. Group use of the area shall be by reservation through the Recreation Director.
- h. Parking of vehicles is permitted only in designated areas.
- i. Use of tobacco products or consumption of alcoholic beverages by participants or spectators during any youth league games, practices, or similar activities is not permitted.
- j. The use of radios, tape players, television, or other electronic sound equipment is permitted, except they shall be played a reasonable manner that does not disturb or annoy other users within the area.
- k. All trash or refuse shall be disposed of by placing in appropriate containers. Users of the trail system and disc golf course shall abide by a carry-in, carry-out policy.
- l. Portions of the trail system may be closed to public use due to trail conditions, weather, or other safety consideration, as may be posted.
