

SEWER RATE POLICY TOWN OF PITTSFORD

1. Billings for construction, operation and maintenance of the Town of Pittsford Water System shall be divided into two categories, as follows and as applicable:

A. BOND CHARGE

1. Each property connected to the Town water system shall share proportionately in the cost of the repayment of the Water System's debt. The Water & Sewer Commission ("Commission") shall assign each property a respective number of ERU's (equivalent residential units), generally relating to the property's calculated maximum daily water consumption using Appendix A, Table 5 of the Vermont Water Supply Rule, or the property's assigned sewer units from the Town, whichever appears to more fairly represent the potential maximum daily water demand for the specific use of the property.
2. In general, a single family living unit (single family house, mobile home, apartment) shall be considered 1 ERU, regardless of population and shall generate a bond charge of \$171.00 each six-month billing cycle.
3. If a landowner feels that he/she has been assigned an incorrect number of ERU's, the landowner may appeal to the Commission, presenting such evidence as the Commission indicates may be necessary for it to consider the appeal. The appeal and the Commission's decision shall be made at a regular or specially warned meeting, shall be in writing and shall include the technical basis for the decision.

B. OPERATION AND MAINTENANCE OF SYSTEM

1. Each property connected to the Town water system shall share proportionately in the cost of operation and maintenance of water system.
 - a. **BASE CHARGE** The billing rate for operation and maintenance shall be a flat cost ("base charge") for the first 6,000 gallons of usage during a six-month billing cycle. This charge will be \$95.00 per ERU.
 - b. **METERED SEWER CHARGE** After the customer has used up its base allotment of water (6,000 gallons per ERU per six-month billing cycle), the customer will pay a sewer charge of \$15.87 per thousand gallons of metered water flow beyond the base allotment.
2. Individual water meters shall be used as the basis to determine actual water usage and related sewer charges. All sewer customers are required to have water meters, located so as to measure total water consumption on the property of water supplied by the Town water system. The only exception to this requirement shall be for those sewer customers who are not also Town Water customers or those sewer customers whose locations where a water meter may not practicably be installed, given the area's

physical limitations (available space, fragile plumbing, etc.). Such unmetered sewer customers will pay a fixed amount equating to an assumed average water consumption amount.

- 3. Operations and maintenance costs shall be annually budgeted by the Select Board.
- 4. The operating budget may include amounts to be transferred into a capital reserve fund and/or vehicle replacement fund, as approved by the Water & Sewer Commission and the Select Board.
